How to prepare the bid:

The bid should contain the following:

- Full name of the bidder,
- Address/location, phone number and Tax ID number (VAT ID number),
- Validity of the quotation,
- The quotation should be signed by a person/people who is/are entitled to conduct legal transactions on behalf of the bidder, the signature should be legible otherwise please use the stamp,

Terms of payment and delivery:

- The value of the object of the contract should be provided in the net price + the VAT, which should be calculated by the bidder according to the local regulations;
- The provided price should include the cost of the object of the contract that meets all specified requirements and all related costs (including delivery cost);
- Prior to the invoice is being issued a delivery and acceptance protocol is drawn up and signed by the responsible person from the ordering company.

Evaluation of the bid:

BIOTON S.A. evaluates all received bids based on the following criteria:

1. Quality of the products and their expiry date,
2. Price and terms of payment,
3. Time of delivery,
4. Experience in the area related to the object of the contract.

The supplier is selected based on analysis of received bids. BIOTON S.A. may ask for some additional information or the meeting in order to clarify any doubts associated with the object of the contract.
